DID YOU KNOW THAT...?

Itap is part of an even larger group of companies, all owned by the Patti family: FINPAT.

Finpat, was founded in 1982 and is the holding company of the group of the same name to which Itap SpA and two other real estate companies, Immobiliare Creta SrI and San Giovanni SrI, belong.

Finpat, to which family members who are not active in Itap also belong, is responsible for holding stakes in the group's companies and overseeing their corporate life; it is a limited partnership limited by shares, an infrequent company form (just over one hundred in Italy) and used almost exclusively in family holding companies due to its particular management characteristics.
